Confirms commitment of \$375,000 from the General Fund to the Bogerts Bridge Restoration Capital Project.

RESOLVED by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County who is requesting a Redevelopment Assistance Capital Program grant of \$750,000 from the Pennsylvania Office of the Budget to fund rehabilitation of Bogert's Covered Bridge committed \$375,000 in matching funds in its 2020 Capital Project Budget.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby confirms commitment of \$375,000 in Capital Project Account #2207 to support the Bogerts Bridge Restoration Project.

The City is submitting a formal application to the State Office of the Budget, for the \$750,000 awarded in Redevelopment Assistance Capital Program (RACP) funds for the Bogert's Bridge Rehabilitation Project. The application requires that 50% of the dollar for dollar required match be secured. The City committed \$375,000 in matching funds in the 2020 Capital Project Budget, for project #2207 Bogerts Bridge. A Resolution is required to confirm the availability of those on-hands funds.
