AN ORDINANCE

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of Two Thousand Four Hundred (\$2,400.00) Dollars from Good Shepherd for the purchase of radio transmitter bracelets for Project Lifesaver clients.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 General Fund in the amount of Two Thousand Four Hundred (\$2,400.00) Dollars reflecting receipt of monies from Good Shepherd as followed:
