AN ORDINANCE

Amending the 2023 Capital Fund Budget to provide for a Two Hundred Seventy-Five Thousand Dollars (\$275,000.00) from the City’s ARPA funds for the repair of the Dixon St. Pedestrian Bridge. These funds will provide for the design and construction of the Dixon St Bridge, which will allow citizens to use this bridge and connect the neighborhoods from the north of Dixon St to South Mountain Middle School and Dodd Elementary school area.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

**SECTION ONE:** That City Council authorizes appropriation in the amount of Two Hundred Seventy-Five Thousand Dollars (\$275,000.00) as follows:

**Parks and Recreation**

**SECTION TWO:** That this Ordinance will take effect ten (10) days after final passage.

**SECTION THREE:** That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

This bill originates from the Parks and Recreation department, with support from Finance.

This bill provides for the repair of the Dixon St. Pedestrian Bridge that has been closed since 2021. This bridge is an important connection from the neighborhood to the north of Dixon St to South Mountain Middle School and Dodd Elementary school area.

The purpose of this bill will provide design and construction of the Dixon St Bridge to bring it back to safe and working conditions to allow citizens to use this bridge again.
