Authorization Change Order with <u>Kuharchik Construction</u>, Inc., for Contract price increase of 10% or more for an existing Contract over \$40,000.00, that was previously Bid and Awarded under City Policies, in the amount of \$41,152.52 for intersection improvements as a result of an accident made to the traffic signals along Lehigh Street and two (2) adjoining street intersections for a total of 15 intersections.

Resolved by the Council of the City of Allentown, That

WHEREAS, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to increase the contractual sum of the previously awarded agreement with the following named contractor/consultant, for the use and purpose indicated in supporting the Contract dated May 22, 2020:

 This recommendation is for a contract consideration increase of 10% or more for an existing contractual sum. Said contract was previously bid and awarded under city policies.

Description of project or scope of services to be provided and why is an increase needed:

On or about April 15, 2020, a bid opening was held of which the City received three (3) bids. The purpose of this Contract is to have improvements made to the traffic signals along Lehigh Street and two (2) adjoining street intersections for a total of 15 intersections, relative to the Green Light Go Grant Project. The work includes improving the intersections to have a functional adaptive traffic signal system along the Lehigh Street corridor. On or about May 13, 2020, City Council approved the Award to Kuharchik Construction.

The contract term commenced on May 22, 2020 and the term was to expire on June 30, 2020. On or about June 3, 2020, a Change Order was submitted to the Change Order Committee to extend the contract term through September 30, 2020, which was approved on June 5, 2020. This did not require Council approval because there was not a contract sum increase of over 10% of the contract sum of \$257,955.00.

On or about August 13, 2020, a second Change Order was submitted to the Change Order Committee for review and approval for a contract sum increase of \$41,152.52, which is over the 10% increase of the contract sum. The said increase is needed due to an automobile accident that occurred on July 20, 2020, at the intersection of Lehigh Street and Glenwood Street/ Route 78 Ramp LB. A vehicle damaged the intersection traffic signal control cabinet. This intersection is one of the ongoing Lehigh Street Corridor System Improvement under the Green Light Go Grant Project.
