AN ORDINANCE

Amending the 2022 General Fund Budget to provide for a supplemental appropriation of Sixty-Five Thousand (\$65,000) Dollars as a result from a grant from the Commonwealth of Pennsylvania Department of Community & Economic Development (PA DCED) Initiative Program to the Allentown Fire Department, Bureau of Emergency Management Services (EMS) to provide funds which will be utilized to purchase an all-terrain ambulance vehicle.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2022 General Fund in the amount of Sixty-Five Thousand Dollars (\$65,000) as a result from a grant from the Commonwealth of Pennsylvania Department of Community & Economic Development (PA DCED) Initiative Program to the Allentown Fire Department as follows:
