Please be advised that the Pennsylvania Liquor Control Board ("Board") approved the petition of the City of Allentown, Lehigh County ("City") on October 6, 2021 in the above-referenced case, for the area designated by the City in its petition to be exempted. This area is exempted from compliance with section 493(34) of the Liquor Code, 47 P.S. § 4-493(34), regarding amplified sound for the period commencing October 6, 2021 and ending at 2:00 a.m. on October 6, 2024. The City's noise ordinance, Article 710 (Noise Control), found in Part Seven of its General Offenses Code, will be in effect during said period. RESOLUTION

R122 - 2021

Introduced by the City Council and the Administration on August 4, 2021

Requests the Council of the City of Allentown to authorize the City Solicitor's Office to file a petition with the Pennsylvania Liquor Control Board to exempt a specific area of the City of Allentown, described herein, from the Pennsylvania Liquor Control Boards regulations regarding amplified music being heard off the licensed premises in favor of enforcing the City's own previously adopted Noise Ordinance, Article 710, of the City of Allentown's Codified Ordinances for five years following the date of approval of this petition.

Resolved by the Council of the City of Allentown, That

WHEREAS, the City of Allentown ("City") has a previously adopted Noise Ordinance Codified as Article 710 and entitled "Noise Control". A true and correct copy of the Ordinance is attached hereto as "ATTACHMENT A" and incorporated herein as is fully set forth; and

WHEREAS, 47 P.S. § 4-493(34) – Unlawful acts relative to liquor, malt and brewed beverages and licenses, places restrictions on the sound level of music or other entertainment inside or outside of licensed liquor establishments; and

WHEREAS, 47 P.S. § 4-494 establishes penalties for violations of the restrictions identified in 47 P.S. § 4-493(34); and

WHEREAS, 47 P.S. § 4-493.1(b) grants local municipalities the right to file a petition with the Pennsylvania Liquor Control Board ("PLCB") for exemption from the requirements of 47 P.S. §4-493(34) regarding amplified music being heard off the licensed premises for all licenses within an identifiable area in the municipality.

WHEREAS, the PLCB requires a resolution from the City confirming support of the filing of a petition to enforce the City's own Noise Ordinance in place of the PLCB's current regulations; and

WHEREAS, the area which will be affected by this decision is specifically described as bounded in "ATTACHMENT B" and more generally described thusly:


Liberty Street from North 17th Street to North 19th Street, and 19th Street from Liberty Street to Tilghman Street, inclusive of the area bounded by:

The line of Tilghman Street from the intersection with 19th Street to the intersection with N. St. George Street.

The line of N. St. George Street from the intersection with Tilghman St. to the intersection with Early Street.

The line of Early Street from the intersection with N. St. George Street continued to N. 17th Street.

The line of N. 17th Street from the connection with the continuation of the line of Early Street to the North Eastern edge of Lehigh Valley Hospital.
