AN ORDINANCE

Amending Part II General Legislation, Chapter 270 Fees, Article XII Fire Fees by creating inspection fees and updating the language of the City Code.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That Section 80 Fees be amended as follows:

ARTICLE XII Fire Fees § 270-80 Fees

- A. The following fee list shall include the places or functions which shall require a Fire Department permit and/or certification. In most cases, the inspection shall be performed annually except where otherwise noted.
- B. A consolidated permit may be issued in cases where occupancy has multiple fees and/or permits required.
 - (1) Open flames and torches (105.6.32): \$30.
 - (2) Open flames and candles (105.6.33): \$40.
 - (3) Bonfires/open burning (105.6.31).
 - (a) Bonfires for one hour: \$175.
 - (b) Bonfires for two hours: \$250.
 - (c) Other open burning (plus cost of Fire Department standby): \$100.
 - (4) Recreational fires and outdoor fires (105.6.55).
 - (a) Campfires: \$50.
 - (b) Other recreational fires and outdoor fires: \$50.

 - (4) Compact disc of fire photos (per operation): \$150.
 - (5) Excessive alarms (three in a thirty-day period): \$300.

 What department or bureau is this bill originating from? Where did the initiative for the bill originate?

The Fire Department through the Fire Prevention office is trying to amend the ordinance 270-80 Fees.

Summary and facts of the bill.

The purpose is to cut down on excessive follow-up inspections for recurring fire permits. This will add a follow-up fee and will be consistent with the Health Dept and Building Standards re-inspection fees, which are already included in the current ordinance.

It allows the Fire Department to charge a fee for the follow-up inspections after the second inspection. It will keep business owners compliant in a timely manner.

It will lower the amount of follow-up inspections and cut down the workload of the City's Fire Marshal, which is already backlogged by inspection schedules.
