BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a Keystone Communities grant of Eighty Thousand (\$80,000.00) Dollars from the Pennsylvania Department of Community & Economic Development to support the renovation and refurbishment of the Police Athletic League building.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Matt Tuerk, Mayor, and Bina Patel, Finance Director, as the officials to execute all documents and agreements between the City of Allentown and the Pennsylvania Department of Community & Economic Development to facilitate and assist in obtaining the requested grant.

This bill is originating from the Police Athletic League.

Summary and facts of the bill.

The City is submitting a formal application to the Pennsylvania Department of Community and Economic Development for \$80,000 from the Keystone Communities Program that will support the renovation of the Police Athletic League building.
