On or about April 1, 2022, the City began the process of conducting an informal quote in order to obtain a Vendor to provide a PennDOT certified signal inspector to assess, document and monitor the operations of the contractor for the Downtown Traffic Signal Improvement Project – Phase I-A, to ensure that the work is being completed in accordance with the project plans and specifications. The inspector will also provide inspection reports for the files, communicate with the City about any unknown field conditions, assist in the payment amounts per month to the contractor, from the City, and perform all documentation with PennDOT through the ECMS systems project files. The City sought out five (5) vendors, three (3) of which declined to submit proposals for various reasons and two (2) vendors sent quotes. McMahon Associates, Inc. was the lowest proposer.
