## AN ORDINANCE

Amending the 2025 Fire Department budget to provide for a supplemental appropriation of Three Hundred Eighty-Eight Thousand Dollars (\$388,000.00) from FEMA US Department of Homeland Security Assistance to Firefighters grant. These funds will be utilized to purchase and install new sprinkler systems in each of the fire stations.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2025 General Fund in the amount of Three Hundred Eighty-Eight Thousand Dollars (\$388,000.00).

This bill originates from the Allentown Fire Department.

Summary and facts of the bill.

An award of new funds is being provided by FEMA US Department of Homeland Security Assistance to Firefighters grant to be used to purchase sprinkler system installations at 4 of the fire stations for the Allentown Fire Department.

These grant funds will help the department for the purchase and installation of automatic sprinkler systems in each of the fire stations, with the lone exception of one station which is slated for demolition. Each of the four stations' current systems are at least 39 years old.

This bill relates to the City's vision and mission by providing equipment to ensure all Fire personnel will be properly trained to protect and serve the citizens of Allentown and provide a safe City for all who live, work and visit the City of Allentown. It has always been the City of Allentown's priority, as well as every elected official to provide safe and efficient Public Safety services to ensure a safe environment.

Grant funding opportunity has been approved in the amount of \$352,727.27 in Federal funding. As a condition of this grant, we are required to contribute non-Federal funds equal to or greater than 10.0% of the Federal funds awarded, or \$35,272.73 for a total approved budget of \$388,000.00.
