AN ORDINANCE

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of Five Hundred Sixty-Two Thousand Dollars (\$562,000) from the Pennsylvania Department of Health, Division of Immunization to assist the City's Health Bureau to accomplish COVID-19 vaccinations, routine vaccines for Children and Act 317 Vaccinations.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 General Fund in the amount of Five Hundred Sixty-Two Thousand Dollars (\$562,000) from the Pennsylvania Department of Health.

## **What Department or bureau is Bill originating from? Where did the initiative for the bill originate?**

The bill originated from the Department of Community and Economic Development, Bureau of Health. An award of new funds totaling \$1,019,377 is being provided by the Pennsylvania Department of Health, Division of Immunizations.

Amending the 2021 General Fund Budget to provide for a new appropriation of Five Hundred and Sixty-Two Thousand dollars (\$562,000) from the Pennsylvania Department of Health.

THIS IS AN EMERGENCY REQUEST. The purpose of the funding is to assist in covering expenses for the Health Bureau's public health response to coronavirus disease (COVID-19). The specific Immunization tasks the bill seeks to accomplish include 1) COVID 19 Vaccination and 2) routine Vaccines for Children and Act 317 Vaccination.

A benefit of this Bill is to enhance Allentown's ability to respond to COVID-19 that is both a global pandemic and local public health emergency. There is no down-side to this funding.

This Bill is congruent with the Health Bureau's mission to prevent disease and injury and to protect and promote the public's health.

Passing this Bill will not result in a financial cost to the City. \$562,000 in new expenditures will be placed in the 2021 budget, with corresponding revenues.

The benefits of the appropriation is to reimburse the City of Allentown for expenses related to the public health response to COVID-19.

The funds being allocated will be used to: 1) prevent the spread of the disease through ongoing COVID 19 Vaccination strategies 2) plan for possible future vaccination efforts; 3) maintain assistance with ongoing immunization response; 4) implement education and awareness campaigns; and 5) purchase equipment and supplies.

The funds are also needed to restore funding to other Health Bureau programs that purchased supplies that were needed immediately for the COVID-19 public health response including Public Health Emergency Preparedness (Program 19).

- **Why should Council unanimously support this bill?**

The goal of public health is to prevent and control the spread of disease. COVID-19 is a global pandemic that requires a local public health response. The Bill allows us to increase grant revenue; helps to cover the public health expenses necessary to respond to this public health emergency; and implement COVID-19 vaccination initiatives including vaccination, education and promotion activities.
