AN ORDINANCE

Amending the 2022 Capital Fund Budget to provide for a transfer of Forty-Nine Thousand Seven Hundred Fifty Dollars (\$49,750.00) from Capital Account (1803) Bridge Repairs to Capital Account (1912) Traffic Signal Modernization to cover the remaining amount needed for the match funds of the MTF-PennDOT grant, which will be used to install traffic adaptive system on 15<sup>th</sup> Street from Tilghman Street to Highland Street. This grant will also cover installing a new school flasher at Trexler Middle School.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer of Forty-Nine Thousand Seven Hundred Fifty Dollars (\$49,750.00) in the following manner:



Department of Public Works – Traffic Planning & Control

- Summary and facts of the bill.

The Bureau of Traffic has applied and been awarded a MTF-PennDOT grant to install traffic adaptive system on 15<sup>th</sup> Street from Tilghman Street to Highland Street. This grant will also cover installing a new school flasher at Trexler Middle School.

The total Grant is for \$1,080,500 of which \$249,750 is City Match funds. This request is to transfer Forty-Nine Thousand Seven Hundred Fifty Dollars (\$49,750) from Capital Account (1803) Bridge Repairs to Capital Account (1912) Traffic Signal Modernization to cover the remaining amount needed for the match funds.

- Purpose – Please include the following in your explanation:
  - a. What does the bill do? What are the specific goals or tasks the bill seeks to accomplish?

The purpose of this resolution is to transfer \$49,750 from Capital Account 1803 (Bridge Repairs) to Capital Account 1912 (Traffic Signal Modernization) to cover the match funds available for this project.

- b. What are the benefits of doing this? What are the drawbacks?

The benefits of doing this resolution is to allocate the necessary funds to complete the project and cover the match funds needed to receive the remaining amount of this grant. The amount awarded for this reimbursable grant is \$830,750 (Total grant amount \$1,080,500 = \$830,750 reimbursable + \$249,750 match funds)

- c. How does this bill relate to the City's vision/mission/priorities?

The grants purpose is to add intersections on 15<sup>th</sup> Street from Tilghman Street to Highland Street onto the Traffic Adaptive System and install a new school flasher at Trexler.
