AN ORDINANCE

Amending the 2025 Capital Fund Budget to provide for an increase of Three Hundred Eighty-Four Thousand Dollars (\$384,000.00) to a newly created capital account and Ninety-Six Thousand Dollars (\$96,000.00) from the unappropriated balance as a grant match for the Demonstration project. These upgrades are low-cost temporary safety improvement projects that will include installing speed cushions, roundabouts, and line painting at key locations throughout the City. The City was awarded a Safe Streets and Roads for All Demonstration Grant and also includes the City's match portion.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the Federal Aid revenue balance of the 2025 Capital Fund in the amount of Three Hundred Eighty-Four Thousand Dollars (\$384,000.00) reflecting receipt of monies from the Safe Streets and Roads for All Demonstration Grant and Ninety-Six Thousand Dollars to the Transfer In revenue balance to reflect receipt of match funding from the General Fund unappropriated balance as follows:
