RESOLUTION

R191 - 2025

Introduced by the Administration on December 3, 2025

Approves the submission of the formal application for the local share account statewide grant for the City of Allentown Parks Department to support the improvements of the Lil Le Hi Trout Nursery.

Resolved by the Council of the City of Allentown, That

WHEREAS, the City of Allentown is desirous of submitting a formal application to the Pennsylvania Department of Community & Economic Development for a grant of seven hundred fifty-eight thousand, one hundred ninety and ten hundredths dollars (\$758,190.10).

NOW, THEREFORE, BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a local share account statewide grant to support the construction of a new park operations facility.

BE IT FURTHER RESOLVED; that the City of Allentown hereby designates Matthew Tuerk Mayor, and Bina Patel, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

This bill originates from the Department of Parks and Recreation

- Summary and facts of the bill.

The City of Allentown is submitting a formal application to the Pennsylvania Department of Community and Economic Development (DCED) for \$758,190.10 awarded from the Statewide Local Share Account (LSA) grant that will support the improvements for the Lil Le Hi Trout Nursery. The LSA funding will be utilized to purchase a new stocking truck, new aerators, and repair the ponds.
