Mr. Craig Messinger stated that this is a rebate. Part of the LED replacement project that we have going on in the city. PPL encourages the city to do this project by giving us rebates to help pay for part of the project to go on. This was for the first part of it. There were about 1,200 lights that were installed and the city filed for the rebate and this is the amount of money being returned to us. He stated that he would like to put it back into the Capital Project so this way the city has the funding for the money for additional LED light replacements.

Mr. Ed Zucal asked if there were any comments from his colleagues.

Ms. Candida Affa asked Mr. Messinger what phase are they in. How many more do we have, the LED.

Mr. Craig Messinger stated that they actually are ordering right now Phase IV of our lights. We actually have a contact that will be going out hopefully in about a month or so to take it out to about 17th Street. Out north to the city line and also lighting in there for the east side and the south side. He stated that the city's next Phase you will see probably half of the city getting done in the next Phase.

Ms. Candida Affa thanked Mr. Messinger.
