Introduced by the Administration on June 13, 2023

Approves the City's application to the PA Department of Health for a grant of Twenty Thousand Dollars (\$20,000.00) that will be used for the City's Community Housing program: Renovate, Repair, and Paint.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requested a grant of Twenty Thousand Dollars (\$20,000.00) from the PA Department of Health. The City of Allentown Department of Community and Economic Development, Community Housing program has been allocated Twenty Thousand Dollars (\$20,000.00). The funding was approved to support the program: Renovate, Repair, and Paint.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates the Mayor and Finance Director as the official(s) to execute all documents and agreements between the City of Allentown and the Department of Justice to facilitate and assist in obtaining the requested grant.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby approves of the grant for Twenty Thousand Dollars (\$20,000.00) in Community Housing funds from the PA Department of Health.

 What department or bureau is this bill originating from? Where did the initiative for the bill originate?

This resolution originates in the Department of Community and Economic Development.

The attached legislation, from the PA Department of Health also serves as the City of Allentown's application and grant acceptance of \$20,000.00 for the program: Renovate, Repair and Paint.

Summary and facts of the bill.

The PA Department of Health has awarded Community Housing \$20,000 for EPA approved Renovate, Repair, & Paint (RRP) training. The goal is to train 100 local contractors, maintenance technicians, property managers, and landlords in safer ways to work with lead painted materials in older buildings. Educating these folks in how to identify and handle lead paint hazards is critical to the reduction of childhood lead poisoning because they are most often the ones in the homes doing the work. Classes will be offered in English and Spanish. The grant period runs until 12/31/2024. Funds would include cost of EPA/RRP training, printed material, class refreshments, and contractor licensing fees.

Consultant/Subcontract Services = \$15k

EPA - Renovate, Repair, & Paint (RRP) Training for up to 100 individuals = 10ppl per class x \$1,500 per class x 10 classes

Other Costs = \$5k

\$4k - Contractor Licensing Fees - PADOLI & EPA as needed for up to 10 Program Contractors = \$400 x 10

\$1k - Class Materials and Refreshments = \$100 x 10 classes

The grant period runs until 12/31/2024. Funds would include cost of EPA/RRP training, printed material, class refreshments, and contractor licensing fees.

b. What are the benefits of doing this? What are the drawbacks?

The goal is to train 100 local contractors, maintenance technicians, property managers, and landlords in safer ways to work with lead painted materials in older buildings. Educating these folks in how to identify and handle lead paint hazards is critical to the reduction of childhood lead poisoning because they are most often the ones in the homes doing the work.

c. How does this bill relate to the City's vision/mission/priorities?

This grant will also be used alongside the Healthy Homes and Lead grant that the city has been doing to reduce lead in homes so we can stop childhood lead poisoning.

This provides the City the ability to expend \$ 20,000.00 in PA Department of Health funds to complete a variety of activities including education, training and to license contractors.
