AN ORDINANCE

Amending the 2021 General Fund budget to create One (1) additional position of Community Health Nurse (11N) in the Allentown Health Bureau (AHB). This position and related expenses will be covered by a One Hundred Thousand (\$100,000) Dollar donation from St. Luke's Physician Group, Inc. to assist the Allentown School District in becoming a Vaccines for Children Provider (VFC).

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 289 of the General Fund budget be amended by adding one (1) Community Health Nurse position (11N) budgeted at an annual salary of Sixty-Five Thousand (\$65,000) Dollars. Twenty-Seven Thousand Five Hundred (\$27,500) Dollars will be needed for the remaining 11 pay periods in 2021.

SECTION TWO: That City Council authorizes an increase to the unappropriated balance of the 2021 General Fund in the amount of One Hundred Thousand (\$100,000) Dollars reflecting receipt of monies from St. Luke's Physician Group, Inc.:

SECTION THREE: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:
