RESOLUTION

R133 - 2023

Introduced by the Administration on August 2, 2023

Authorizes the submission of the formal application for a Pennsylvania DCED Emergency Solutions Grant in the amount of Five Hundred Thousand Dollars (\$500,000.00) to benefit Lehigh Valley Regional Homeless Advisory Board members. This grant will allow sub-recipients to provide homeless services and resources to the region's homeless population.

Resolved by the Council of the City of Allentown, That

WHEREAS, the City of Allentown is desirous of obtaining funds for The Lehigh Valley Regional Homeless Advisory Board from Pennsylvania DCED for Rapid Rehousing, Street Outreach, Emergency Shelter, Homeless Prevention and HMIS under 24 CFR § 576.102 and 24 CFR § 576.104.

NOW, THEREFORE, BE IT RESOLVED, that shelter and homeless needs exist and have been identified in the local Consolidated Plan and the proposed grant activity addresses this need.

BE IT FURTHER RESOLVED, the City of Allentown will conduct the required citizen participation process.

BE IT FURTHER RESOLVED, the City of Allentown Department of Community and Economic Development (DCED) will assure the provision of other necessary funds to make the activity feasible.

BE IT FURTHER RESOLVED, that DCED will reimburse the commonwealth for any expenditures found by DCED to be ineligible.

BE IT FURTHER RESOLVED that the appropriate officer of the City of Allentown is directed to execute a certificate attesting to the adoption of this Resolution and to furnish a copy of this Resolution to Department of Community and Economic Development (DCED).
