AN ORDINANCE

Amending the 2024 Capital Fund Budget to provide for a supplemental appropriation of Two Hundred Twenty-Eight Thousand Nine Hundred Thirty Dollars and Fourteen Cents (\$228,930.14) from UGI for the purpose of construction ADA handicap ramps and for the milling and paving of streets under the City's Utility Paving Program.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the City Council authorizes a supplemental appropriation of Two Hundred Twenty-Eight Thousand Nine Hundred Thirty Dollars and Fourteen Cents (\$228,930.14) as follows:

Public Works - Engineering

- Summary and facts of the bill.

This bill would authorize the acceptance of \$228,930.14 from UGI that the City has negotiated for the purpose of construction of ADA handicap ramps and for the milling and paving of streets under the City's "Utility Paving Program".

By collaborating with UGI through this Cost Share Program to pave the streets and replace the ADA handicap ramps, it will relieve homeowners of the financial burden.

This bill will allow the Department of Public Works to make road improvements on streets where UGI has completed gas main replacements.

- i. Purchasing materials for paving and pavement markings in work area due to replacement of UGI mains and services.
- ii. Preparation of the contract for construction of ADA handicap ramps at the main intersection or work area.

Funding is provided for the materials to pave the streets and replace the ADA ramps on the Cost Sharing Program which relieves the homeowners of the financial burden.
