Resolved by the Council of the City of Allentown, That

WHEREAS, the City of Allentown is desirous of obtaining additional funds for The Lehigh Valley Regional Homeless Advisory Board from Pennsylvania DCED for Rapid Rehousing, Street Outreach, Emergency Shelter, Homeless Prevention and HMIS under 24 CFR § 576.102 and 24 CFR § 576.104

NOW, THEREFORE, BE IT RESOLVED, that shelter and homeless needs exist and have been identified in the local Consolidated Plan and the proposed grant activity addresses this need.

BE IT FURTHER RESOLVED, the City of Allentown will conduct the required citizen participation process.


