AN ORDINANCE

Amending the 2024 Capital Fund Budget to provide for an appropriation in the amount of Sixty-Five Thousand Dollars (\$65,000.00) from the Trexler Fund to the WPA Structures capital projects account. These funds will be used to repair the stairs Union Terrace Park and is part of the 2024-25 Trexler Capital Project allocation.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer in the amount of Sixty-Five Thousand Dollars (\$65,000.00) from the Trexler Fund to the WPA Structures capital projects accounts in the following manner:
