AN ORDINANCE

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of Fifty Thousand One Hundred Twenty-Eight Dollars and Thirteen Cents (\$50,128.13) from the Municipal Police Officer's Education and Training Commission (MPOETC) for tuition and salary reimbursement from Act 120 Training to be used to purchase duty weapons and holsters for new hire Patrolmen.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 General Fund in the amount of Fifty Thousand One Hundred Twenty-Eight Dollars and Thirteen Cents (\$ 50,128.13) from the Municipal Police Officer's Education and Training Commission.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.
