AN ORDINANCE

Amending the 2026 Capital Fund and General Fund Operating Budgets to provide for a supplemental appropriation of One Hundred Thousand (\$100,000.00) Dollars from the Allentown Parknership to support improvements to Ithaca Park and Recreational Programming. This is a reimbursement from the Parknership.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the 2026 Capital Fund in the amount of Forty-Three Thousand (\$43,000.00) Dollars and the 2026 General Fund in the amount of Fifty-Seven Thousand (\$57,000) Dollars from the Allentown Parknership.

SECTION TWO: That City Council authorizes a supplemental appropriation to the balances of the Capital and General Funds as follows:
