AN ORDINANCE

Amending the 2026 General Fund Budget to provide for a supplemental appropriation of Sixteen Thousand (\$16,000) Dollars from Urban Sustainability Director’s Network (USDN) to conduct a pilot citizen science project with the City of Easton, Community Bike Works, and Pennsylvania State University.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the revenue balance of the 2026 General Fund in the amount of Sixteen Thousand (\$16,000.00) Dollars from Rockefeller Philanthropy Advisors as follows:

SECTION TWO: That City Council authorizes a supplemental appropriation from the Parks General Fund balance as follows:

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

This Bill seeks to accept a grant of \$16,000 from USDN's Q1 2026 Catalyst Fund to conduct a citizen science project in collaboration with the City of Easton, Community Bike Works, and Pennsylvania State University.

The Bill appropriates the grant funds, \$3,600 will be used to purchase air quality and heat monitors and other supplies necessary for testing, \$6,400 will be sent to Community Bike Works to support data collection and civic education and outreach, and \$6,000 will be provided to Faculty from Pennsylvania State University to support the hiring of Civic SciTech Fellows to support the technical portions of the project

- b. What are the benefits of doing this?

The citizen science project will collect localized heat and air quality data and the project will provide an opportunity to demonstrate how government, higher education, and community-based organizations can engage in citizen science to better support the needs of communities. Recommendations that come from the project can be included in the City's Climate Action Plan and Urban Forestry Master Plan, both of which are currently in development.
