Mr. Andrew Theyken Bench, 131 N Eighth Street, talked about the quality of life over the last three or four years. He came here in construction and did construction on a house that was a condemned building that he got from the city of Allentown. The permit process was hell. He paid the almost \$10,000 to the city of Allentown and time and time again it was one of the most frustrating and annoying things. He is an attorney and an assistant district attorney and have dealt with every bureaucracy from the local level up to the highest courts in the country and the city of Allentown permitting was horrible. He gave a shoutout to Paul and Dottie are amazing and they should be paid more. He would have gone insane if it was not for those two. He talked about the police quality of life. He had an opportunity to talk to the new Police Chief about the dirt bikes. It is something to be looked at and the double parking issue. He talked about the Allentown Parking Authority and stated that he is a pretty law abiding guy and an assistant district attorney and got four or five street cleaning repeat offender violations. Where he lives just by the flow of traffic, you have to move your car about 16 times a week for street cleaning. That is a lot. Paying attention to it, he gets tickets.

Mr. Julio Guridy thanked Mr. Theyken Bench and stated that there are members of the administration here and he is sure they are taking notes. All your comments will be taken into consideration.

Mr. Thomas Houck, 845 N. Eighth Street, suggested that have City Council put out some type of Resolution or document to the newspaper in recognition and remembrance of September 11th which is coming up this

weekend. It would be very appropriate for this city for the amount of veterans that we have in this city. Veterans are extremely disillusioned on what happened in Afghanistan. He is going to an event on Saturday, September 11th at the South Mountain Grove which is called Brothers to Brothers. Council gives a three minute time limit to individuals and a five minute time limit. Yet under your actual Rules under D. It says Citizens Right to be Heard will be the first order of business and before any vote on City Council, the public will be granted to comment to City Council without time limit except when the Council President poses a reasonable time limitation deemed necessary. The Home Rule Charter may require some updating if it has been changed. It does not look like change have come about on Citizens Rights to be Heard.

Mr. Julio Guridy thanked Mr. Houck and stated that it has been Council Rules for a very long time. It is in writing in the front when you see the Agenda.

Mr. Craig Messinger stated that the upgrades that are being taken care of right now in our downtown area to Tilghman Street. They also looking to do the corridor for Hanover Avenue. For the bus rapid transit that takes that corridor along with us doing that process at that time. We will be able to work with LANTA in their project along with that to provide safe routes for them. Recommends Policies Requiring Vaccinations and Masking to Maintain and Add Social and Economic Value to our Community

Mr. Julio Guridy asked Ms. Affa, Ms. Mota and Mr. Siegel if they had any comments. Any comments from the dais?

Mr. Thomas Houck, 845 N. 18th Street, stated that if he understands this Resolution correctly, it is a recommendation. It is nonbinding on our businesses or people in the city. He asked is he mistaken with that.

Mr. Joshua Siegel stated that Resolutions have no legal authority.

Mr. Thomas Houck stated on the Resolution all the way at the bottom, Now, therefore be it resolved. He stated that he has no problem with Number 1. getting the vaccine and masking up. That is a very appropriate recommendation. He has been vaccinated, but his wife on the other hand can't be because she has a very unique medical condition and was told if she wants to get the vaccine, she has to spend 48 hours in the hospital when she receives it. They won't even administer it outside a hospital setting. His discern comes from the other three recommendations. Certain people on Council has voiced their respect if they will for the rights of the citizens and concerns of the citizens. It goes against that. Recommending businesses and local governments considers vaccinations as a requirement of work. Our city already has a time getting people to work in this city right now with everything that has been going on. There are help wanted signs all over the city and passing this Resolution and making that recommendation is counterproductive. If an individual business to want to do that, that is fine. For the city to take the initiative and try to encourage that is extremely counterproductive. The third item is encouraging all businesses to require proof of vaccinations to enter. This has been addressed through the federal levels and state levels. We can argue HIPAA and everything else, but he will not go into a business that is going to ask him about his personal medical record. He stated that the final one is examining or establishing an insurance premium or no sick day policy for non vaccinated individuals. First off, most people have contracts. You are going to violate contracts if you encourage businesses to pursue this. No sick day policy for a non vaccinated individuals if they are sick because of Covid. You are going to deny them the right to use sick days just because the fact that they did not get vaccinated. He stated that is a bit of socialism if you asked him.

Mr. Julio Guridy thanked Mr. Houck and asked if there were any other

questions from the public. He stated that he is a little bit concerned about the last one too. If somebody is sick and establishing an insurance premium or no sick day policy.

Mayor Ray O'Connell stated that the key word is recommends. There is a difference between recommends and mandates.

Mr. Julio Guridy stated that it is, but still.

Mayor Ray O'Connell stated that a definition of recommends is that he gives Mr. Guridy a recommendation. You don't have to follow it. If he gives him a mandate, you will have to follow it.

Mr. Julio Guridy stated that it is a recommendation and he understands that. It is a tough one.

Mr. Thomas Houck stated that he doesn't believe that it is a recommendation that the city should be making.

Ms. Candida Affa asked Mr. Houck if his wife can be vaccinated, but can wear a mask.

Mr. Thomas Houck stated that she cannot be vaccinated unless she does it in a hospital stay. He stated that you do realize that the CDC says the mask does not protect you, it protects him from her.

Ms. Candida Affa stated to Mr. Houck that she does not want to put his wife in jeopardy by not getting vaccinated or wearing a mask.

Mr. Thomas Houck stated that he understands it is a recommendation, but he feels that it is a recommendation that we as a city should not be making.

Ms. Ce Ce Gerlach stated that for the one encouraging businesses to require proof of vaccination to enter. She remembers speaking to a nonprofit during the peak of all of this. He expressed that he wished the city would require contact tracing and support the businesses and nonprofits to do the contact tracing. If this were to pass, do we have the capacity if we are going to encourage businesses to require proof of vaccinations to help the businesses do that.

Ms. Candida Affa stated that they can mask.

Ms. Ce Ce Gerlach stated for Number 3 is a small business to require proof of vaccination to enter. She stated that she heard from people some of their concerns that owns small businesses.

Mayor Ray O'Connell stated that the city does not have the resources to do that.

Mr. Joshua Siegel stated that he will respond to Ms. Gerlach's point because it is an excellent point and one of his primary concerns for small businesses. The city itself does not have the resources, but he will say that there are a number of Apps that have been invented since Covid Pandemic began which is free to utilize. You take a picture of your vaccination card and you bring it up on your phone. It is a very quick verification process. There are software and systems out there that will enable small businesses to fairly easily comply with this. It is as simple as showing your cell phone with your vaccination card. There are many different resources for small businesses to make that a reality. The city can facilitate by pointing them in the right direction. New York City was the first city to mandate proof of vaccination requirements for entry. Obviously, somebody is going to slip through the cracks. He is one of the sponsors of the Resolution and Mr. Houck is correct, it is a Resolution so at most it is a simple suggested piece of language. It is important and you see many area of businesses and hospital networks in particular begin to mandate vaccinations as a requirement for employment. He stated that he thinks that is the right step to do. There is a lot of miscommunication in this country right now and in the society we make sure we sacrifice and there is a solidarity aspect to living in America and sometimes we do stuff for each other as a sacrifice. We wear masks to protect each other. You get vaccinated to protect each other. He stated that he does believe if you want to participate in society willfully and freely, you should have to get the vaccination to enter a business. If you don't, you are free to live your own life in your own home, but you are not free to threaten the lives of other people. The Delta Variant has shown just how effective the vaccine is in protecting us. he stated that 99.9 percent of all hospitalizations are the result of people not vaccinated. Breakthrough cases are very rare. Individuals who do get Covid that are vaccinated is very light and non threatening. The reality is that we do not have to change the way we live for the unvaccinated. It is the other way around. We will not put people's lives in jeopardy because people refuse to follow the science or refuse to follow the facts and chose to live their lives irresponsibly. Inoculations and mandatory vaccinations are a result of this country itself. George Washington mandated smallpox vaccinations among troops at Valley Forge. He stated that he does not want to hear about your freedoms or your right to live you life as you want. You will not put people's lives in jeopardy. He stated that is why he believes this Resolution is so important. If we want to get his country back opened, back to normalcy, it starts with vaccinations and it starts with shared sacrifice. That is why he believes this Resolution is important and that is why he brought it forward. It is at best a

recommendation. This sends a message in the city. It has a lot of symbolic value and is important. We spent over a year sacrificing in many ways. If you want to get back to business and you are pro small business and pro freedom then you really need to support everybody getting the vaccination so that we can finally open our country back up for good.

Ms. Candida Affa stated that the PPL Center and most football events are now saying you can't get in unless you are vaccinated and you have a card. We in city hall is not a business. If we cannot mandate it for the people that work here every day. She stated that she may go to a meeting and sit in a small room with someone that is not vaccinated and we speak many times, the mask is off. She stated that they are putting her life in jeopardy. We just opened Council up after almost a year and look and look how we have to sit. We are protecting each other by wearing a mask. We are not a small business, but she believes we have to sacrifice and save each other.

Mr. Julio Guridy stated that he is going to vote for it and thinks everybody should be vaccinated period. His only concern is it is unenforceable. It is a good recommendation. He asked if there were any further comments from the public.

Mr. Andrew Bench stated that to Mr. Siegel that was the best defense of masks and vaccinations he ever heard. He appreciates someone saying it.

Ms. Candida Affa stated that she wants to address everyone out there that are listening or streaming or anyone that is here. As the president noted that she and Mr. Hendricks are on the board of the Parking Authority. She stated that they get monthly reports throughout the meeting. She stated that parking tickets are a necessary evil. She is sure everyone of her colleagues have gotten phone calls that ever they are not double parked, they are not double parking enough, or a citizen was just taking groceries in and they go a ticket for double parking. There was a situation that a person was going into work and they were taking things in and taking things out of the car. Obviously, the person had to be there for a while for the officer to come up, observe the car and give the ticket. It had to be a good five or 10 minutes. She stated that she just got a parking ticket going to Damascus. She got a ticket for street cleaning and had to pay it. This is the last report they got for July and they had 95 double parking tickets on Seventh Street. Total to date on Seventh Street, is 780 parking tickets. That is 140 better than all of 2020. The APD (Allentown Police Department) had 64 tickets. On Seventh Street alone, 95 double parking tickets and 780 up to date. Call for service is 24/7, except Saturdays and Sundays in one year it was 13,000 calls for service. She is here not to just defend the Parking Authority, but to try to understand how difficult it is in the city where 10 years ago or 20 years ago we did not have this major problem. Everybody has three or four cars. If you go down the street any day on Seventh Street or Walnut Street, it is packed. The Allentown Parking Authority is out there doing a job as the Allentown Police Department is also. They get \$13,000 a year for Calls for Service. It could be a call for booting or someone in their driveway. She just got a complaint from a doctor at an alley on 15th Street that he cannot get out because the person across the street constantly parks in front of his garage. He has called the Parking Authority and the Parking Authority has ticketed them and the Parking Authority says that if he tells them he is a doctor and he has an emergency, they will tow it. She stated that she and Mr. Hendricks are there to protect the citizens and to make sure that the Parking Authority is doing the right thing.

Mr. Julio Guridy stated that he is one of the people who enacted the double parking tickets back in the day and it is a good deterrence. We have people that just abuse it. He stated that he does not have a problem. Basically, leave it up to the Police Department when they are around to give tickets for double parking. An attorney was complaining on having to pay \$75 to park in a garage for every month. The Parking Authority's

meeting are once a month at 12:00 noon.

Ms. Candida Affa stated yes and you can attend. it is at 12:00 noon, the fourth Wednesday of the month.

Mr. Julio Guridy stated that it is on Sixth and Linden Streets.

Ms. Ce Ce Gerlach stated that the one lady lived at Seventh Street was concerned because her residential parking was being taken away and she was being told she had to pay that \$75 a month to park in the lot. She could not afford that since she is on a fixed income. Do we know if that was resolved or the residential parking is being taken away.

Mr. Daryl Hendricks stated that they have sent letters out. They have been working on that and formulating what the final plan will be. They now have a lot there. The way the law is written is when you have more than 50 percent of a block that is commercial business, residential parking no longer applies. The area on Seventh Street is 90 percent commercial business.

Ms. Ce Ce Gerlach asked if the Parking Authority working to possibly make it a little more attainable for the residents there.

Mr. Julio Guridy stated that there are a lot of residents that live on the second floor.

Ms. Ce Ce Gerlach stated that most buildings have residents and many who are low income. She asked about communication that some of them were involved. There was a conversation on social media on people who don't pay their parking tickets. Parking tickets that lead to arrests and then lead to incarceration. She knows there is an item number that says that someone can serve 10 days in jail for not paying. If you don't pay your tickets, can you go to jail.

Ms. Candida Affa stated that she spoke to John Morgan. The Parking Authority has no right to arrest anyone. The Allentown Police Department can.

Chief Charles Roca stated yes, but during this time in the pandemic it has been suggested that it would not be a wise idea. It is on the books, but the Police Department will use their discretion.

Ms. Ce Ce Gerlach stated that she would like to remove that. She does not feel people should be in jail. She does not care if they owe \$1,000. You should not be sitting in jail because you owe parking tickets.

Ms. Candida Affa stated that all the states have it. It is not something new to Allentown. What do you do for a person that owes \$2,000 worth of parking tickets.

Ms. Ce Ce Gerlach stated that would have to be a conversation that they have. She does not think that people should be sitting in a jail cell for not paying tickets.

Mr. Julio Guridy asked if there were anything under Good and Welfare.

Mayor Ray O'Connell stated that the administration and City Council gave their deepest condolences of the loss of his mother. He stated that he knew if mother and knows his father. They are great people. He stated that Rhoda was a great educator in Allen High School and his two kids had her and they got good grades from her.

Mr. Julio Guridy thanked Mayor O'Connell for bringing that up. He stated that 911 is coming up and he stated that Council should do a Resolution or Proclamation.

Mayor Ray O'Connell stated that he agrees with Mr. Houck. He said the military was the primary focus of your talk.

Mr. Thomas Houck stated that there were a lot of veterans in the city and it will be appropriate for City Council.

Mayor Ray O'Connell stated that he does not disagree with him, but the brunt of the work goes to the first responders, the Police, Fire and paramedics. He stated that his sons was up there doing a job at Merrill Lynch. Our heart goes out. There was a parade in Easton on Saturday, Towers II Tunnel. The first responders were there along with military veterans. In America we have very short memories. We should not just remember on 911, but when we wake up with gratitude for the police, fire, and EMS. We should never forget.

Mr. Julio Guridy stated that people are giving their lives here to keep us safe.
