## Introduced by the Administration on December 7, 2022

Authorization for a change order with Omnes LLC in the amount of \$20,870.00 for a landscape architectural firm, to have on retainer, that will provide services that are inclusive of, but not be limited to, City-wide architectural design services, project management and project implementation for City owned and private properties. The initial sum as \$50,000, the total sum will be for 70,870. The City anticipates future projects, in designing outdoor areas, landmarks, and structures to achieve aesthetic outcomes.

**WHEREAS,** Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

**WHEREAS,** it is the desire of the City of Allentown to increase the contractual sum of the previously awarded agreement with the following named contractor/consultant, for the use and purpose indicated in supporting the Recommendation of Award or Contract dated December 16, 2019:

Description of project or scope of services to be provided and why is an increase needed:

OMNES is the landscape architect of the project responsible for the design. In the inclusion of the design is the types of plants and trees to be done in any of the planters and tree pits. OMNES as part of being the architect takes site visits to ensure the plants and trees are being installed properly. The inspection that OMNES does would be for time of year, depth along with the lay out that was specified on in the design. For instance, if OMNES saw that trees were planted to deep they would request the landscaper to come back and replant them under their supervision. The types of trees being planted are to be planted in the spring as per OMNES and the nursery at which they are being purchased. OMNES will also go to the nursery to hand pick the trees in the best condition for the streetscapes needs.

The original terms are the contract shall be effective upon execution and shall cease three (3) years thereafter, with no renewals. Due to supply chain issues and weather, an extension is needed to be able to finish the project. A one (1) year extension is being requested.

This contract has an estimated budget, not to exceed, sum of \$50,000.00 for the entire contractual term. The payment of expense was thought to be completed by 12/16/2022 however weather and supply chain issues require an Increase in the sum.
