AN ORDINANCE

Amending the 2021 Capital Fund Budget to provide for a supplemental appropriation of Two Hundred and Fifty Thousand (\$250,000) Dollars as the result of a grant from the Commonwealth of Pennsylvania Department of Community & Economic Development (PA DCED) Initiative Program to the Allentown Fire Department to provide funds to be utilized for costs associated with the construction of the Fire Academy Public Safety Training and EOC building, including appliances and furnishings.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 Capital Fund in the amount of Two Hundred and Fifty Thousand (\$250,000) Dollars as a result from a grant from the Commonwealth of Pennsylvania Department of Community & Economic Development (PA DCED) Initiative Program to the Allentown Fire Department to provide Funds which will be utilized for costs associated with the construction of the Fire Academy Public Safety Training and EOC building, including appliances and furnishings.

Allentown Fire Department

- **Summary and Facts of the Bill**

The Allentown Fire Department was awarded a grant from the Commonwealth of Pennsylvania Department of Community & Economic Development (PA DCED) Initiative Program for funds that will be utilized for all costs associated with the construction of the Fire Academy Public Safety Training and EOC building, including appliances and furnishings.

- **What does the Bill do – what are the specific goals/tasks the bill seek to accomplish**

The Bill will provide funding for the purchase of much needed Fire Academy and EOC Building for the Allentown Fire Department. This funding establishes the funds necessary to for all costs associated with the construction of the Fire Academy Public Safety Training and EOC building, including appliances and furnishings. This addition will assist with the efficiency and services provided by the Allentown Fire Department which will result in life safety to the citizens of Allentown.

- **What are the Benefits of doing this/Down-side of doing this**

Benefits - This allows us to build a facility that would meet the needs of the Fire Department for training purposes. This facility would also serve as an emergency operations center which would allow the emergency management coordinator to operate from a remote site for coordination of services during any type of emergency where multiple agencies would be involved. Downside – There are no downsides to this addition to the Fire Department and a city as a whole.

This Bill relates to the City's vision and mission by providing a facility to ensure all Fire personnel will be properly trained to protect and serve the citizens of Allentown and provide a safe City for all who live, work and visit the City of Allentown. It has always been the City of Allentown's priority, as well as every elected official to provide safe and efficient Public Safety services to ensure a safe environment.
