AN ORDINANCE

An Ordinance of the City of Allentown, County of Lehigh, and Commonwealth of Pennsylvania, establishing the General Fund, Administrative Order Fund, Risk Management Fund, Debt Service Fund, Equipment Fund, and Golf Fund Budgets for 2026.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the following financial program is hereby adopted for the year 2026, and appropriations are made to the various departments as indicated in the section below.

SECTION TWO: That the sum of One Hundred Fifty Million, Six Hundred Forty-Eight Thousand, Seven Hundred Nineteen (\$150,648,719) Dollars, net of a planned vacancy factor of Two Million Four Hundred Thousand (\$2,400,000) Dollars, be hereby appropriated as follows:

SECTION THREE: That a tax for general revenue be levied for the fiscal year, beginning the first Monday of January, A.D., 2026, upon all real, personal and mixed property within the limits of the said City, taxable according to the laws of the State of Pennsylvania, the valuation of such property to be taken from the assessed valuation of the taxable property under the provisions of the law regulating the same, at the rate of Four and Five Thousand Two Hundred Ninety-Three Thousandth (4.5293) mills on improvements and Twenty-Four and Four Thousand Seven Hundred Five Thousandth (24.4705) mills on land.

SECTION FOUR: That an appropriation in the sum of One Million One Hundred Eighteen Thousand Twenty (\$1,118,020) Dollars is hereby made to the Lease/Administrative Order Fund as more fully detailed in Exhibit A, "City of Allentown 2026 Budget."

SECTION FIVE: That an appropriation in the sum of Thirty-Three Million Ninety-Nine Thousand Three Hundred Fifty-Eight (\$33,099,358) Dollars is hereby made to the Risk Management Fund as more fully detailed in Exhibit A, "City of Allentown 2026 Budget."

SECTION SIX: That an appropriation in the sum of Eight Million Three Hundred Sixty-Six Thousand Two Hundred Thirteen (\$8,366,213) Dollars is hereby made to the Debt Obligation as more fully detailed in Exhibit A, "City of Allentown 2026 Budget."

SECTION SEVEN: That an appropriation in the sum of One Million Two Hundred Forty-Six Thousand (\$1,246,000) Dollars is hereby made to the Equipment Fund as more fully detailed in Exhibit A, "City of Allentown 2026 Budget."

SECTION EIGHT: That an appropriation in the sum of Two Million Nine Hundred Nine Thousand Seven Hundred Ninety-Seven (\$2,909,797) Dollars is hereby made to the Golf Course Fund as more fully detailed in Exhibit A, "City of Allentown 2026 Budget".

SECTION NINE: That all Ordinances or parts of Ordinances conflicting with the provisions of this Ordinance be and the same are hereby repealed.

SECTION TEN: That this Ordinance takes effect January 1, 2026.

An Ordinance of the City of Allentown, County of Lehigh, and Commonwealth of Pennsylvania, establishing and adopting the Building Code Fund Budget for 2026 for Community and Economic Development per Chapter 270 of City code for Building Fees.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That an appropriation in the sum of Three Million Two Hundred Twenty Thousand Five Hundred Sixteen (\$3,220,516) Dollars is hereby made to the Building Code Fund as more fully detailed in Exhibit A, "City of Allentown 2026 Budget."

SECTION TWO: That Chapter 270, Community and Economic Development Fees Ordinance of the City of Allentown, and the same is hereby amended establishing the Building Fees outlined therein.

SECTION THREE: That all Ordinances or parts of Ordinances conflicting with the provisions of this Ordinance be and the same are hereby repealed.

An Ordinance of the City of Allentown, County of Lehigh, and Commonwealth of Pennsylvania, establishing and adopting the Rental Unit Licensing Fund Budget for 2026 and amending Article 1759 – Landlord and Rental Fee by maintaining the Residential Rental Fees.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That an appropriation in the sum of Three Million Ninety-Three Thousand Five Hundred Eleven (\$3,093,511) Dollars is hereby made to the Rental Unit Licensing Fund as more fully detailed in Exhibit A, "City of Allentown 2026 Budget."

SECTION TWO: That Section 1759, Landlord and Rental of the Codified Ordinances of the City of Allentown, be and the same is hereby amended establishing the Residential Rental Fees outlined therein.

An Ordinance of the City of Allentown, County of Lehigh and Commonwealth of Pennsylvania, establishing and adopting the Solid Waste Enterprise Fund Budget for 2026 and amending Article 1131, Municipal Waste Storage, Collection and Disposal by increasing the Solid Waste Fee at Seven Hundred Forty (\$740) Dollars.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That an appropriation in the sum of Twenty-Eight Million Nine Hundred Sixty-Two Thousand One Hundred Eighty-Six (\$28,962,186) Dollars is hereby made to the Solid Waste Fund as more fully detailed in Exhibit A, "City of Allentown 2026 Budget."

SECTION TWO: That Section 1131.02, Authorization of City Contractor(s); Scope of Work; Fee, Subsection (C), Municipal Waste and Recycling Fee, of the Codified Ordinances of the City of Allentown, be and the same is hereby amended establishing the Solid Waste Fee at Seven Hundred Forty (\$740) Dollars.

SECTION THREE: That all Ordinances or parts of Ordinances conflicting with the provisions of this Ordinance be and the same are hereby repealed.

SECTION FOUR: That this Ordinance takes effect January 1, 2026.

An Ordinance of the City of Allentown, County of Lehigh and Commonwealth of Pennsylvania, establishing and adopting the Stormwater Fund Budget for 2026 and amending Article 393.15 – Stormwater Utility Fee by maintaining the Stormwater Utility Fee at Twenty (\$20) Dollars per Five Hundred (500) square feet of impervious surface.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That an appropriation in the sum of Six Million Five Hundred Ten Thousand Eight Hundred Fifty-Two (\$6,510,852) Dollars is hereby made to the Stormwater Fund as more fully detailed in Exhibit A, "City of Allentown 2026 Budget."

SECTION TWO: That Section 951.03, Imposition of Stormwater Utility Fee of the Codified Ordinances of the City of Allentown, be and the same is hereby amended establishing the Stormwater Utility Fee as Twenty (\$20) Dollars per Five Hundred (500) square feet of impervious surface.

SECTION THREE: That all Ordinances or parts of Ordinances conflicting with the provisions of this Ordinance be and the same are hereby repealed.
