AN ORDINANCE

Amending the 2021 Capital Projects Fund and the 2021 Trexler Fund to provide for a transfer of Three Hundred Ninety-Nine Thousand Three Hundred Twelve Dollars and Thirty Cents (\$399,312.30) from the Trexler Fund Capital Contribution Account to Capital Project 2213 (Valania Park Renovations) and Capital Project 2206 (Jordan Creek Greenway Trail).

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer from the Trexler Fund to the Capital Fund in the following manner:

Department of Parks and Recreation

- **Summary and Facts of the Bill**

Appropriate \$399,312.30 from the Trexler Trust into the capital fund. As per the agreement between the City and the Trexler Trust, 20% of the total award to the City from the Trust is to be appropriated for capital projects. \$300,000 should be placed into the Jordan Creek Greenway Trail (2206) and \$99,312.30 should be placed into Valania Park Renovations (2213).

- **What does the Bill do – what are the specific goals/tasks the bill seek to accomplish**

Appropriate \$399,312.30 from the Trexler Trust annual award to the City. As per the agreement between the City and Trexler Trust, 20% of the total award is to be appropriated for capital projects.

Appropriate \$300,000 to Jordan Creek Greenway Trail (001-08-2206-2160-46) and \$99,312.30 to Valania Park Renovations (001-08-2213-2160-46)

- **What are the Benefits of doing this/Down-side of doing this**

Appropriating these funds completes the City's 20% obligation towards capital projects. The Jordan Creek Greenway Trail will complete a vital link of the Department's goal of connecting our community to the park system via trails.

The funds for Valania Park will assist with the costs of renovations to a historic and important park for the community that resides around it.

It fulfills the City's obligation to apply 20% of the Trexler Trust funds for 2021 towards capital projects. The funds will be used to assist in the completion of the Jordan Creek Greenway Trail and for the renovation of Valania Park.
