AN ORDINANCE

Amending the 2023 Capital Fund Budget to provide for a supplemental appropriation of One Hundred Thousand (\$100,000.00) Dollars from the Pennsylvania Department of Conservation and Natural Resources (DCNR) to support a comprehensive Parks Master Plan.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2023 Capital Fund in the amount of One Hundred Thousand (\$100,000.00) Dollars from the Pennsylvania Department of Conservation and Natural Resources. Dollars as follows:
