**Authorization for a Receivables Contract with Ross Body & Frame Works Inc (d/b/a A-1 Towing), with a revenue generating total of \$1,085,100.00 for year 2026, 2027, and 2028, and a the estimated expense amount of \$4,000.00 per year for the contractor to tow City vehicles at one-half the rates established in the bid. This contract is to hire a highly qualified company to provide towing, storage and impounding services to the City of Allentown, 24 hours a day, 365 days a year. The City shall at all times receive priority service. Work under this project shall include locked, fence-enclosed lighted compound area, preferably attended for security purposes. This project was competitively bid, one (1) response was received. The contract shall commence on January 1, 2026, and shall be for three (3) years with two (2) additional one (1) year renewals beyond the contract expiration period.**

- Description of project or scope of services to be provided:

On September 22, 2025, the City advertised for sealed bids from qualified vendors to provide towing and storage services for vehicles damaged in accidents, abandoned, nuisance, and/or impounded vehicles, or snow emergency towing within the City. On October 20, 2025, a public opening was held, for which one (1) bid was received. Upon review of the bid, it was determined to award to Ross Body & Frame Works Inc.

- Contract Term:

The Contract term shall commence on January 1, 2026, and shall cease on December 31, 2028.

- List any renewal term options and duration of each renewal, if any:

Upon written notification from the City, this contract can be extended for up to an additional two (2) one (1) year renewals beyond the contract expiration period at the same annual terms of the initial term.

- Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

Optional – Towing Services for the Year 2029: \$362,400.00

Optional – Towing Services for the Year 2030: \$362,400.00

Totaling – \$1,809,900.00 if all renewals are utilized.

A vote of final approval is requested of the members of Council and by passing the accompanying resolution, this Contract will be deemed approved and awarded.
