AN ORDINANCE

Amending the 2025 Fire Department budget to provide for a supplemental appropriation of Seventy-Six Thousand Six Hundred Dollars (\$76,600.00) from FEMA US Department of Homeland Security Assistance to Firefighters grant. These funds will be utilized to purchase of Fire Alarm System installations at four of the fire stations for the Allentown Fire Department.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2025 General Fund in the amount of Seventy-Six Thousand Six Hundred Dollars (\$76,600.00).

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Fire Department budget as follows:

SECTION THREE: That this Ordinance takes effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

This bill originates from the Allentown Fire Department.

- Summary and facts of the bill.

An award of new funds is being provided by FEMA US Department of Homeland Security Assistance to Firefighters grant to be used to purchase a fire alarm system at 4 of the fire stations for the Allentown Fire Department.

 - a. What are the specific goals or tasks the bill seeks to accomplish?

These grant funds will help the department for the purchase and installation of fire alarm systems in each of the fire stations, with the lone exception of one station which is slated for demolition. Each of the four stations' current systems are at least 39 years old.

This bill relates to the City's vision and mission by providing equipment to ensure all Fire personnel will be properly trained to protect and serve the citizens of Allentown and provide a safe City for all who live, work and visit the City of Allentown. It has always been the City of Allentown's priority, as well as every elected official to provide safe and efficient Public Safety services to ensure a safe environment.

Grant funding opportunity has been approved in the amount of \$69,636.36 in Federal funding. As a condition of this grant, we are required to contribute non-Federal funds equal to or greater than 10.0% of the Federal funds awarded, or \$6,963.64 for a total approved budget of \$76,600.00.
