Authorization for Contract with Simone Collins, Inc, a small business, in the estimated sum of \$199,999 to provide consulting, design, planning, and development of cost estimates to assist the in completing a comprehensive plan for city parks and recreation. The goal is to solicit public input to develop a list of priority projects and programs that meet the needs of the residents. There were five (5) bids, one (1) rejected due to including cost in their technical; one (1) year contract that can be extended for up to and additional three (3) months beyond the contract expiration period.

WHEREAS, Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

1. Name of Contractor/Consultant: Simone Collins, Inc.
2. Project or Contract Reference: RFP No. 2024-11 Comprehensive Recreation and Park Plan
3. Description of Service(s): To provide detailed consulting and planning services for design, planning, and development of cost estimates to assist the City of Allentown in completing a comprehensive plan for city parks and recreation. - Description of project or scope of services to be provided:

On April 10, 2024, the City advertised a solicitation for a firm to provide detailed consulting and planning services for design, planning, and development of cost estimates to assist the City of Allentown in completing a comprehensive plan for city parks and recreation. The goal is to solicit public input to develop a list of priority projects and programs that meet the needs of the residents. On May 8, 2024, there was a public opening held, which five (5) proposals were received, however, one (1) proposal was rejected due to including cost in their technical proposal. The remaining four (4) proposals were distributed to all committee members via Teams for evaluation. The Technical evaluation was held on May 15, 2024, all committee members were present. The proposals were scored based on the following: IBE Preference (10 Points), Proposals and Experience (25 Points), Methodology (25 Points), Timeline (20 Points), and References (15 Points). The Cost proposals were opened on May 15, 2024, and distributed to all committee members via Teams for evaluation after the completion of the Technical evaluation. The Cost evaluation was held on May 23, 2024, all committee members were present. The committee members discussed the Cost proposals (15 Points). The committee did not feel it was necessary to move forward with oral presentations. The evaluation committee completed both Technical and Cost evaluations on the proposals, the committee decided to award based on the firm qualifications and overall score. The committee is recommending award to Simone Collins, Inc.

- Contract Term:

The Contract term shall commence upon full execution and shall cease one (1) year thereafter.

Upon written agreement, this contract may be extended for up to and additional three (3) months beyond the contract expiration period.
