AN ORDINANCE

Amending the 2024 General Fund Budget to provide for a supplemental appropriation of Seven Hundred Fifty (\$750.00) Dollars from Keep PA Beautiful in their efforts to support a volunteer event by Giant/Martin Food Stores for supplies to conduct the volunteer event.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase appropriation of the 2024 General Fund in the amount of Seven Hundred Fifty (\$750.00) Dollars reflecting receipt of monies from Keep PA Beautiful:
