AN ORDINANCE

Amending the 2026 Trexler Fund by authorizing a supplemental appropriation in the amount of Three Hundred Twenty-Two Thousand Nine Hundred Fifty-Five Dollars and Fifty Cents (\$322,955.50) to the Parks and Recreation Department to support the operating and capital budgets. This is inclusive of the City Match required in the agreement which needs to correspondingly increase Eighteen Thousand Two Hundred Eighty Dollars and Fifty Cents. (\$18,280.50) to follow the 6% match requirement. This is part of the 2026 Trexler Capital Project allocation.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation from the unappropriated balance of the 2026 Trexler Fund in the amount of Three Hundred Four Thousand Six Hundred Seventy-Five Dollars (\$304,675.00) and a supplemental appropriation from the unappropriated balance of the 2026 General Fund in the amount of Eighteen Thousand Two Hundred Eighty Dollars and Fifty Cents (18,280.50) as follows:

SECTION TWO: That City Council authorizes a supplemental appropriation in the amount of Three Hundred Twenty-Two Thousand Nine Hundred Fifty-Five Dollars and Fifty Cents (\$322,955.50) as follows:
