The subject portion of Skyline Drive is in the 15th Ward. Skyline Drive has a 50.0' wide Right of Way and was dedicated by Marvin Shaffer, Anne Shaffer, Stanley Shaffer, Harold Caplan & Agnes Caplan in Deed Book 1215 Page 373 on February 19th, 1976.








Proposed Street Vacation
