AN ORDINANCE

Amending the 2025 Capital Fund Budget to provide for a supplemental appropriation of Seven Hundred Fifty Thousand Dollars (\$750,000.00) from the Redevelopment Assistance Capital Program (RACP), Commonwealth of Pennsylvania, to support the rehabilitation of Bogert's Bridge.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2025 Capital Fund in the amount of Seven Hundred Fifty Thousand Dollars (\$750,000.00) from the Redevelopment Assistance Capital Program (RACP), Commonwealth of Pennsylvania, as follows:

The purpose of this ordinance is to appropriate the revenue and expenses of the \$750,000 Redevelopment Assistance Capital Program (RACP) grant for Bogert's Bridge rehabilitation from the Commonwealth of Pennsylvania. This project will rehabilitate the bridge, which is a historic bridge located in the city's Lehigh Parkway.
