Introduced by the Administration on November 13, 2019

Authorizes Submission of an Application to the Pennsylvania Department of Transportation Multimodal Transportation Fund for a Grant of ONE MILLION SIX HUNDRED THOUSAND DOLLARS (\$1,600,000) for the Jefferson Street Corridor project.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a Multimodal Transportation Fund Grant of \$1,600,000 from the Pennsylvania Department of Transportation to fund traffic calming and safety improvements along the Jefferson Street Corridor.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Ray O'Connell, Mayor, and Brent Hartzell, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for One Million Six Hundred Thousand Dollars (\$1,600,000) in Multimodal Transportation Funds to the Department of Transportation.
