AN ORDINANCE

Amending the 2024 Community Development Department budget to provide for a supplemental appropriation of Thirty Thousand Dollars (\$30,000.00) from a Commonwealth of Pennsylvania, Department of Health Unintentional Injury Prevention Program (UIPP) grant for fall prevention safety equipment and training.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation to the 2024 General Fund revenues in the amount of Thirty Thousand Dollars (\$30,000.00).

The Allentown Health Bureau has received additional funding from the Unintentional Injury Prevention Program (UIPP) grant through the PADOH. This funding is to provide additional fall prevention training for staff and purchase fall prevention safety equipment for fall prevention clients.
