AN ORDINANCE

Amending the 2024 Capital Fund Budget to provide for an increase of Three Hundred Fifty Thousand Dollars (\$350,000.00) to the Capital Project Martin Luther King Jr. Drive. These funds have been awarded as an MTF-DCED grant and will be reimbursed when the project is completed. The project includes the replacement of the existing rusted streetlights with 24 new LED luminaires and street light poles.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a decrease to the unappropriated balance of the General Fund in the amount of Three Hundred Fifty Thousand Dollars (\$350,000.00) and transferred to the following account:

Public Works – Traffic Planning and Control

Summary and facts of the bill.

The City was awarded a MTF-DCED grant in the amount of \$350,000. As part of the grant requirements, the City needed to provide a \$54,000 match. The match funds have been secured; however, the grant funds of \$350,000 need to be transferred into the capital account so the work can be done. Since this is a reimbursable grant, the funds will be reimbursed to the general fund capital fund account (001-7144) when the project is completed. The total estimated project cost will be \$404,000.

This grant is to upgrade the streetlights along the northside of Martin Luther King Jr. Dr., from 8th Street Bridge eastward to 4th and Union Street. The project includes the replacement of the existing rusted streetlights with 24 new LED luminaires and street light poles.

This bill is to transfer funds from the unappropriated balance to the capital account MLK Jr Dr Lighting (2038).
