Authorization for Contract with BankFunding, LLC. in the amount of \$622,860.95. To finance one (1) Seagrave Marauder Pumper for five (5) years. Two (2) proposals were received; however, one (1) proposal was rejected.

**WHEREAS,** Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

On July 18, 2025, the City advertised to secure a vendor for the financing of one (1) Seagrave Marauder Pumper. The lease will go for five (5) years, with the payment being due March 30 every

year of the contract. On August 7, 2025, a public opening was held, for which two (2) proposals were received. One (1) proposal was rejected due to them not signing their signature page. At this time, the City is recommending award to BankFunding, LLC.

Contract Term:

Five (5) years (2026, 2027, 2028, 2029, 2030). The initial payment shall be due March 30, 2026, the following payments shall be due each year by March 30<sup>th</sup>.
