Introduced by the Administration on July 24, 2024

Approves the submission of an application for a grant from the Commonwealth of Pennsylvania Department of Community and Economic Development for the improvements of Andre Reed Park. The City is asking for \$250,000.00 in grant funding with a 15% match required – land appraisal or cash.

Resolved by the Council of the City of Allentown, that

WHEREAS, the City of Allentown is desirous of obtaining funds from the Commonwealth of Pennsylvania Department of Community and Economic Development.

NOW, THEREFORE, BE IT RESOLVED, the Greenways, trails, and recreation program (GTRP) will allow funds for the improvements of Andre Reed Park.

BE IT FURTHER RESOLVED, the City of Allentown Department of Parks and Recreation will assure the provision of other necessary funds to make the activity feasible.

BE IT FURTHER RESOLVED that the City of Allentown does hereby designate Matt Tuerk, Mayor and Bina Patel, Director of Finance as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.

BE IT FURTHER RESOLVED that the Greenways, trails, and recreation program grant will tentatively fund \$250,000.00.

BE IT FURTHER RESOLVED that the appropriate officer of the City of Allentown is directed to execute a certificate attesting to the adoption of this resolution and to furnish a copy of this resolution to The Commonwealth of Pennsylvania Department of Community and Economic Development.
