AN ORDINANCE

Amending the 2024 Capital Fund Budget to provide for a supplemental appropriation of Two Hundred Fifty Thousand (\$250,000) Dollars from the Pennsylvania Department of Community and Economic Development (DCED) to support improvements to Cedar Beach basketball courts and Midway Manor, installation of the mini-pitch system, and youth sports marketing and outreach.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2024 Capital Fund in the amount of Two Hundred Fifty Thousand (\$250,000.00) Dollars from the Pennsylvania Department of Community and Economic Development as follows:

Parks and Recreation

Purpose of the ordinance is to appropriate the revenue and expenses for the Department of Community and Economic Development (DCED) grant to support improvements to Cedar Beach basketball courts and Midway Manor, installation of the mini-pitch system, and youth sports marketing and outreach. City received a \$250,000 grant to support this design and construction phases.
