Authorizes the submission of a Formal Application for funding from the Pennsylvania Department of Community and Economic Development Multimodal Transportation Fund Grant in the amount of approximately Three Million Dollars (\$3,000,000) to complete a StreetScape Project on Jordan Street from Turner to Gordon Street.

Resolved by the Council of the City of Allentown, That

WHEREAS, the City of Allentown is desirous of obtaining funds from the Pennsylvania Department of Community and Economic Development Multimodal Transportation Fund Grant. This project will enhance and improve two blocks of Jordan Street and will include upgraded ADA compliant sidewalks, trees, lighting, and street paving.

WHEREAS, this project supports Allentown's vision of creating a safe, healthy, and connected city by improving pedestrian infrastructure, accessibility, and neighborhood livability.

NOW, THEREFORE, BE IT RESOLVED, that the Allentown City Council hereby authorizes the City of Allentown to submit the application for approximately Three Million Dollars (\$3,000,000) to the Pennsylvania Department of Community and Economic Development Multimodal Transportation Fund Grant.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Matt Tuerk, Mayor, and Bina Patel, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Pennsylvania Department of Community and Economic Development Multimodal Transportation Fund to facilitate and assist in obtaining the requested grant.
