***Resolved by the Council of the City of Allentown, That***

**BE IT RESOLVED**, that the City of Allentown, Lehigh County hereby requested a FY2022 Statewide Local Share Account Grant of \$779,228.00 from the Commonwealth Finance Authority. Funding will support the City's purchase of a new fire truck for fire department.

**BE IT FURTHER RESOLVED**, that the City of Allentown hereby designates the Mayor and Finance Director as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth to facilitate and assist in obtaining the requested grant.

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the City of Allentown, hereby approves of the grant submission for Seven Hundred Seventy-Nine Thousand Two Hundred Twenty-Eight Dollars (\$779,228.00) in Local Share Account funds from the Commonwealth Finance Authority.
