## Introduced by the Administration on April 17, 2024

Acceptance of Love Your Block Grant Funds for Neighborhood Revitalization through Civic Engagement.

## Resolved by the Council of the City of Allentown, That

**WHEREAS**, the City of Allentown has been selected to participate in the Love Your Block program's 2024-2026 city cohort, receiving a grant of one hundred thousand dollars (\$100,000) from the Bloomberg Center for Public Innovation at Johns Hopkins University over the next two years to hire a Love Your Block Fellow and support community-led revitalization projects;

*WHEREAS,* the Love Your Block grant will enable Allentown to engage residents and community partners in positive neighborhood change, fostering stronger, more resilient communities;

*NOW, THEREFORE, BE IT RESOLVED,* that the City of Allentown gratefully accepts the Love Your Block grant awarded by the Bloomberg Center for Public Innovation at Johns Hopkins University.

**BE IT FUTHER RESOLVED;** that the City of Allentown commits to utilizing the grant funds to hire a Love Your Block Fellow and support community-led revitalization projects as outlined in the award letter.

**BE IT FURTHER RESOLVED;** that the City of Allentown hereby designates Mayor Matt Tuerk and Finance Director Bina Patel as the official(s) to execute all documents and agreements related to the Love Your Block grant on behalf of the City of Allentown.

The bill originates from the Mayor's Office of Civic Innovation. The City of Allentown applied for and was accepted to the Love Your Block 2024-2026 Cohort. Love Your Block is a program of the Bloomberg Center for Public Innovation at Johns Hopkins University.

This resolution seeks to accept a grant of \$100,000 awarded to the City of Allentown by the Bloomberg Center for Public Innovation. This award will create a Love Your Block program in the City of Allentown, managed by the Mayor's Office of Civic Innovation, which will provide for the hiring of a Love Your Block fellow and support community-led revitalization projects through mini-grants.
