Mr. Julio Guridy asked if there were any comments from the dais.

Mr. Ed Zucal stated that last year or the year before we gave a gentleman \$25,000 to be a part of doing research on whether or not a home will be a part of the Historic District and the enforcement of that. What are we doing here?

Ms. Sarrah McNeil stated that this is to provide assistance to the city. She is not sure exactly what he is talking about because she was not there during that time. She stated that she can do research for him.

Ms. Irene Woodward stated that Eastern Architect does the assistance with reviewing all the Certificate of Appropriateness. They provide staff reports to our HARB. They attend those meetings and provide recommendations.

Mr. Ed Zucal stated that the city paid \$25,000 either last year or the year before for someone to do this. Whatever happened to that?

Ms. Irene Woodward stated that it was a different Historic Study. We received other fund and they undertook a review of the Hamilton Street corridor to examine what properties were significant and rated all of those. We do have a complete study on that. This is ongoing assistance to the city's Historic and Architectural Review Board. They are slightly different projects.

Mr. Ed Zucal asked if they were doing the say thing.

Ms. Irene Woodward stated that when somebody is trying to make a change to a historic building, they go before that board and as part of that Easton Architects reviews each application to make sure what those recommendations what they are being proposed are consistent with the city's ordinance. They provide staff support and review of those.

Mr. Julio Guridy asked Mr. Zucal if he is asking if there is any difference from the previous architect then this architect.

Mr. Ed Zucal stated that it is a different vendor so obviously it is probably differences. He stated that it sounds to him that he is doing the same thing as the first guy did. That is what he is asking.

Ms. Irene Woodward stated that the other one was Artifact and she no longer wishes to continue. Currently, Easton Architects is the one doing the work for 2021. Previous to that and for many, many years it was Artifacts. A different architectural firm. Maybe that was the confusion.

Mr. Julio Guridy stated that is what he thought. She is no longer providing service to the city. He stated that he does not think she is in Bethlehem either. He asked Ms. McNeil if there were any further comments or from the dais. Any comments from the public.

Ms. Sarrah McNeil stated that this was done as Quote 2021-17. It was advertised on Public Purchase. It was accessed by 19 vendors and only one quote was received. The department is recommending an award to Iconic Windows. The cost of the contract is \$4,945.

Mr. Julio Guridy asked if there was any comments from the dais.

Mr. Daryl Hendricks stated that he has a question not a comment. How many of our staff will be attending this workshop.

Ms. Irene Woodward stated that it won't just be for city staff. We are doing some outreach to have a number of individuals that would participate that we can show. The city is working with the Historic Districts and the existing organizations. We have not finalized the numbers, but we are opening it. It won't just be city staff. We want to show people in the community that this

is the first time doing it, but will establish a program to teach people how they can restore existing historic windows as opposed to how to replace them. It will include some outreach to some neighborhood groups. It won't just be city staff.

Mr. Daryl Hendricks asked if she had an estimate on approximately how many you anticipate will be attending.

Ms. Irene Woodward stated that she can get that information.

Mr. Julio Guridy asked if anybody else had any further comments.

Mr. Ed Zucal asked why wouldn't this be a workshop for the homeowners. Who on city staff would be doing this?

Mr. Julio Guridy stated that she said it will be for the public as well.

Mr. Ed Zucal asked who on the city staff will be restoring the windows on the HARB properties.

Mr. Julio Guridy stated that the inspectors need to know what is going on.

Mr. Daryl Hendricks stated that it will be some of our inspectors. You do the inspections within the historic district.

Mr. Ed Zucal stated that is fair enough.

Mr. Julio Guridy stated that it is a good project. It is well due and something that is good spend of the money. If he could do it, he would take it. He does not know if he could do two days of it. There are a lot of people that get fees and fines and go through all kinds of things because they don't know what they are dealing with.

Mayor Ray O'Connell stated to Mr. Guridy is right. A couple of years ago said had he known that he could not put them on, the aluminum. He said he would have done it the right way. We are trying to get everyone on the right page to do it the right way.

Mr. Julio Guridy stated that there was someone that brought 20 something windows at one time on 11th or 12th Street. That was years ago. That is a shame. It is good. He asked if there were any comments from the public.

Mr. James Whitney, Walnut Street, stated that he is ok with the price for this. It sounds like we will have a pretty expensive event. It will be a real shame if only 20 or 30 even citizens out of 120,000 showed up to this. He

does not know if necessary if it will have a huge impact. If we make note to request from the people and giving the workshop, they leave us with a kind of a one or two page synopsis of this program that we can hand out subsequently to members of the public who did not attend. That would be something that would give us a lasting benefit from this \$5,000 expenditure. Is that something we have looked in to?

Mayor Ray O'Connell stated that is a good idea.

Ms. Irene Woodward stated that this funding is supported by a grant that they received from the Pennsylvania Historical Museum Commission. We did receive funding for this. This is the first time we are doing it. We are kind of establishing a program. The intent is also to build out so we can replicate this whether it is city staff. The intent is that we can share this information as we go forward. The goal is to train people so they understand how to fix those windows as opposed to having to replace them. It is not just the city staff. It is also the public and also someone that might become a contractor that they can create it as a business and they can help assist other homeowners. We also recognize that it is a lack of that in the community.

Mr. Julio Guridy asked Irene if she has an idea when it is going to happen.

Ms. Irene Woodward stated that their goal is maybe later this year or early spring. It really depends a little bit on the weather. We want to have part of it outside just because of Covid and everything. She stated that they are working with the contractor getting everything together.

Mr. Julio Guridy encourage them to do more of this type of things, not only on windows, but other things in the Historic District. He thinks it would be really good for our citizens, especially those that are moving in. He encouraged them to reach out to the Hispanic community, especially through La Mega Radio Station and some of the other outlets out there that are in Spanish. He is saying La Mega because that is the most recent one. You can do Latina or O'Connell Radio Stations.

Mr. Ed Zucal asked can you advertise so that the general public can attend.

Ms. Sarrah McNeil stated that she can see if they can advertise since they have free advertising on Facebook. We can put it on our Facebook page and we definitely can push this out there as much as possible to get as many people to come.

Mr. Julio Guridy stated that it would be really good.

Ms. Cynthia Mota asked is it possible to reach out to the real estate agencies out there. It is important for the realtors for them to know what is going on. A lot of people buy homes and they don't give them the whole story behind it. It creates a lot of problems. She stated that she thinks it would be a good idea.

Mr. Julio Guridy stated that he has not heard much of the Historic Preservation Resolutions coming over to City Council lately for some reason. He doesn't know if people are not coming in or they are doing a great job or what it is.

Mr. Michael Hanlon stated that there are a bunch on the agenda tonight.

Mr. Julio Guridy stated that the ones that are here, but before that we have not heard hardly any throughout the year. He asked if there were any comments from the public.

Controllers Report

Mr. Jeffrey Glazier stated that the Report you got is the second quarter of the Cash Flows for the three Pension Funds (Police, Fire and O&E). The brief market returns continue to be strong so far this year. The funds are doing well. He stated that the retirement assumptions for the Police Fund were updated and that is going to cost us a little bit of money. The second is that the interest rate assumption that the city uses for all three Pension Funds has been reduced which also is going to cost us a

little bit of money. It is a little bit of paying up front, but it will lead to stronger Pension Funds down the road and we will be better able to weather any of the financial challenges that are thrown at us. It was a very astute move to make those two changes this year. When the third quarter is done and he will report to them on that as well.

Mr. Julio Guridy stated great. We don't have to continue to raise money or sell anything because the Pension Fund is strong.

Mr. Jeffery Glazier stated that they are pretty good. The 205 Report will be released in November and he can report on that in late November, the beginning of December. That will give you the funding levels for the funds.

Mr. Julio Guridy asked there an Actuarial Report being done right now or is it next year.

Mr. Jeffrey Glazier stated that the Actuarial Report is completed. It is getting ready to be released. It would be released to the Pension Boards in November and he will report to Council on it.

and very appropriate to add that amendment.

Mr. Julio Guridy thanked the Mayor and stated that is why he made it.

Mr. Julio Guridy asked if there were any comments on the dais on the Bill itself.

Mr. Daryl Hendricks stated that this gives another tool to the police to enforce this against the people who damage at great cost pieces of valuable equipment that the Parking Authority uses in cases of people who has exerting numerous tickets and have refused to pay them. it is a good move and something that they can utilize against law breakers.

Ms. Ce Ce Gerlach stated that she do with hesitation support this. It would be helpful that the Parking Authority would give us some data. She has been here long enough and on the School Board to know that you make decisions based on data. We don't have a lot of that data concerning this.

Mr. Julio Guridy asked what kind of data are you referring to Ms. Gerlach.

Ms. Ce Ce Gerlach stated that Council got round about numbers. We were told about 85 a month and about 1,000 a year. It would be nice to know the exact numbers like we want for everything else. Based on those estimates, she did some quick math and it seems like anywhere between 1.3 - 1.4 percent of boots that are issued at least in this last given year are either missing or damaged. She does not know if this is modeled after Reading's Ordinance and how that compared to Reading. If Reading has a substantially higher percentage which is why they have that on the books. it would be nice to know that. We don't. Many of them did not know it was modeled after Reading until tonight. She went on and saw that it was there. It is verbatim. It would be great to get that geographical data as well because she is sure none of us would want certain communities to be disproportionately impacted when some of us live in a more congested dense areas that get patrolled by police officers more often. We are more likely to be seen doing something versus other areas or not. That is always a factor. With that said, she is going to hesitantly support this and look forward to soon having a conversation about not putting people in jail for unpaid parking tickets.

Mr. Julio Guridy stated that he can tell Mr. Whitney that it is not in Center City. He asked that same question today.

Mr. James Whitney stated that he is equally concerned for any

neighborhood. He stated that he wants a homeless shelter. He just wants the public whether they are from the eastside or westside or any community to have participation in choosing where we think this homeless shelter would be and not just for the benefit of the people that live in the communities that may be impacted by its presence, but also for the residents of that homeless shelter to make sure that they are in an environment that is conducive to their health. As we decide where we are going to buy a building for a homeless shelter, he thinks public input would be so crucial in that.

Ms. Ce Ce Gerlach stated that she believes that the Homeless Commission is being consulted. They had a presentation. That is what Mr. Lightner said the last time that they have been part of this. Depending on what type of building it is, if there are any type of zoning changes she believes that she was always told to go to the Zoning Hearing.

Mr. Julio Guridy stated that there are a lot of people that talked about this issues. He stated that he has the same sentiment he has in regards to where is it. At this point, he understands and respects that could change the price of it and a lot other things.

Mayor Ray O'Connell stated that there will be public input when we get down the line.
