AN ORDINANCE

Correcting Ordinance 15511, Section Two, by appropriating the correct total of Two Hundred Fifty Thousand (\$250,000) Dollars from the Pennsylvania Department of Community and Economic Development to the City of Allentown for the Multimodal Transportation Fund Grant for the Phase II LED street lighting system along American Parkway from Union Street to Bradford Street rather than Two Hundred Thirty-Two Thousand (\$232,000) which was previously approved into the 2019 Capital Fund.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2019 Capital Fund in the amount of Eighteen Thousand (\$18,000) reflecting receipt of monies from the Pennsylvania Department of Community and Economic Development; previously appropriated Two Hundred Thirty-Two Thousand (\$232,000) Dollars.

- **Summary and Facts of the Bill**

This bill reflect the Multimodal Transportation Fund (MTF-DCED) grant reimbursement for the total amount of \$482,000 (phase 1 at \$232,000 and phase 2 at \$250,000) for the American Parkway Lighting project. The total estimated cost for this project will be \$697,000; this total amount includes the City's match amount of \$213,085 for phase 1 and phase 2.

This bill will provide for the installation of new LED street light installation along American Parkway from Union Street to Bradford Street. In addition, the lighting control system to monitor the operation failure and control will also be installed. This will help motorist see the roadway and increase the safety at night time.

The total estimated cost for this project will be \$697,000. The City created a capital account for this project. The grant amount of \$482,000 will be received as per the reimbursement agreements. The City has to spend the required match amount of \$213,085 towards the design and/or construction of this project; \$215,000 has been set aside in a short-term loan for this purpose.

Completion of the project will help motorist see the roadway and increase the safety at night time along American Parkway from Union Street to Bradford Street.
