### AN ORDINANCE

Amending the 2016 General Fund and the 2016 Equipment Fund budgets by transferring \$100,000 from the unappropriated balance of the General Fund to the Equipment Fund to cover the cost of purchasing a 2016 cab and chassis for the remounting a 2010 Ambulance Box.

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund in the amount of One Hundred Thousand Dollars (\$100,000.00) as follows:

SECTION TWO: That City Council authorizes an increase to the unappropriated balance of the Equipment Fund in the amount of One Hundred Thousand Dollars (\$100,000.00) reflecting a transfer from the General Fund.

SECTION THREE: The City Council authorizes a supplemental appropriation from the unappropriated balance of the Equipment Fund as follows:

This Bill is being initiated by the Department of Public Works.

## Summary and Facts of the Bill

The cab and chassis of a 2010 ambulance needs to be replaced while the ambulance box is still in good condition and able to be used. However, this is an unbudgeted expense and therefore needs to come from the unappropriated balance of the General Fund.
