Introduced by the Administration on August 20, 2025

Authorization for Contract with USI Insurance Services, LLC in the amount of \$160,000.00 per contract year for the services related to the design, implementation, analysis, maintenance, improvement and communications of an employee and retiree benefits and wellness program. Five (5) proposals were received, contract shall be for three (3) years with two (2) additional one (1) year renewals beyond the contract expiration period.

WHEREAS, Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

1. Name of Contractor/Consultant: USI Insurance Services, LLC
2. Project or Contract Reference: RFP 2025-15 Consulting Broker Services for Employee and Retiree Benefits
3. Description of Service(s): To hire a professional, highly qualified benefits brokerage and consulting firm to provide a full suite of services related to the design, implementation, analysis, maintenance, improvement and communications of an employee and retiree benefits and wellness program.

- Description of project or scope of services to be provided:

On April 14, 2025, the City advertised to hire a professional, highly qualified benefits brokerage and consulting firm to provide a full suite of services related to the design, implementation, analysis, maintenance, improvement and communications of an employee and retiree benefits and wellness program. On May 12, 2025, a public opening was held, for which five (5) proposals were received, the proposals were distributed to all committee members via Teams for evaluation. The Technical Evaluation was held on June 26, 2025, all committee members were present. The proposals were scored based on the following: IBE Preference (10 Points), Qualifications of Entity and Key Personnel (20 Points), Approach to delivering Workscope Services (30 Points), and Innovations/Creative Approach to Service Delivery (10 Points). The Cost Proposals were opened on June 26, 2025, and distributed to all committee members via Teams for evaluation after the Technical evaluation. The Cost evaluation was held on July 1, 2025, all committee members were present. The committee discussed the Cost proposals (30 Points). The committee decided to move forward with Oral presentations with the top four (4) scoring firms: Alera Group, Inc., McGriff Insurance Services, LLC, The Equinox Agency, LLC, USI Insurance Services, LLC. The Oral presentations were held on July 28, 2025, all committee members were present. The committee discussed the Oral presentations (15 Points) The committee is recommending award to USI Insurance Services, LLC.

- Contract Term:

The contract shall commence on January 5, 2026, and shall cease three (3) years thereafter

- List any renewal term options and duration of each renewal, if any:

Upon written agreement, this contract may be extended for up to two (2) additional one (1) year terms beyond the contract expiration period.

- Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

\$160,000.00 annual fee totaling \$800,000.00, if all renewals are exercised.

* USI will offset any commissions that are inherently embedded in separate benefit service provider agreements via credit to annual compensation.

A vote of final approval is requested of the members of Council and by passing the accompanying resolution, this Contract will be deemed approved and awarded.
